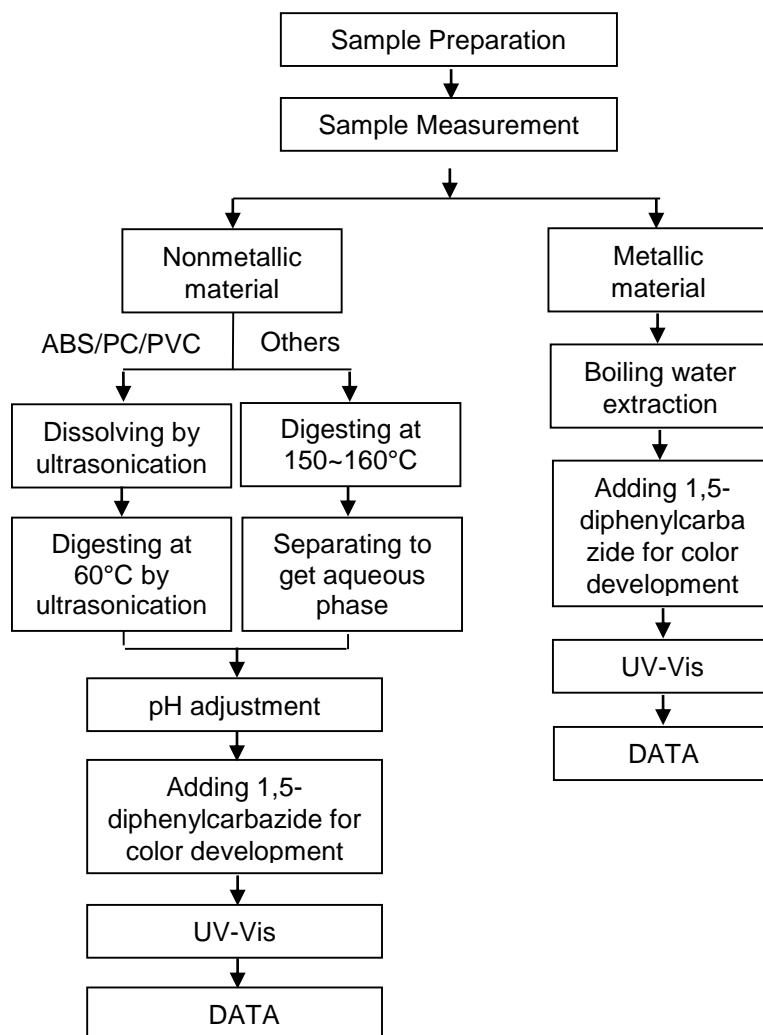

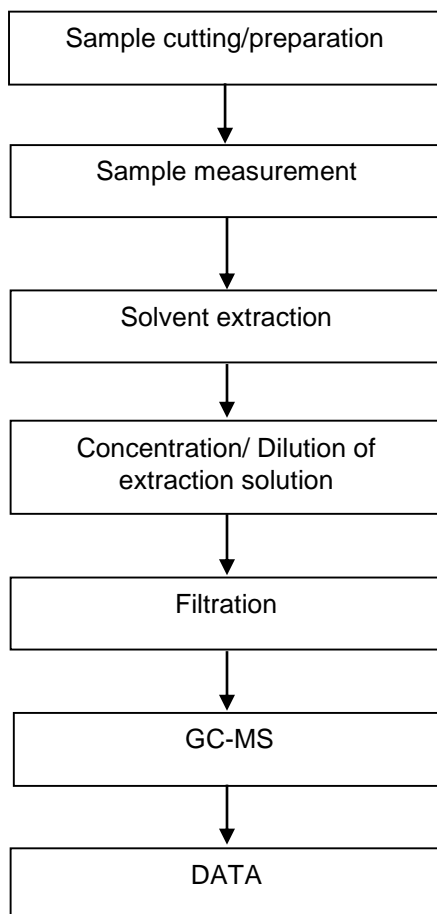

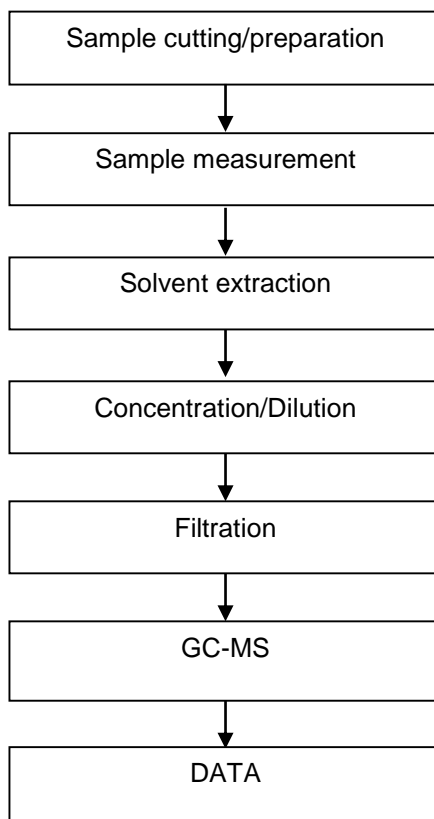

Phthalates Testing Flow Chart



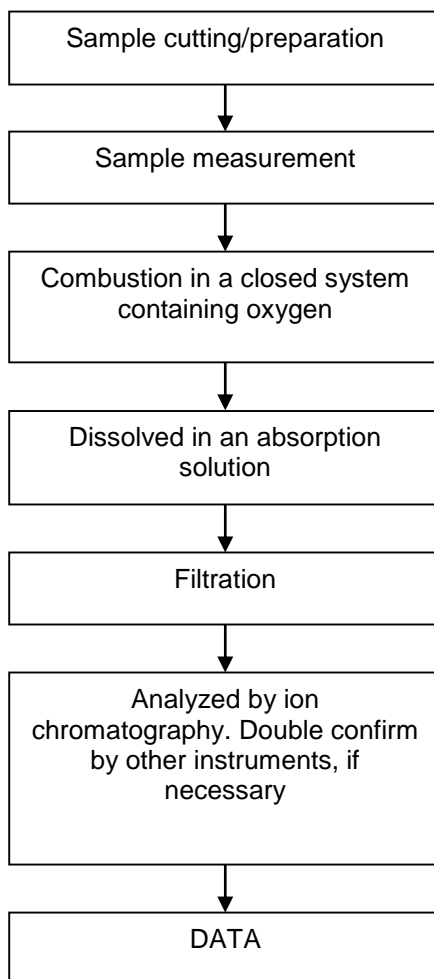
