





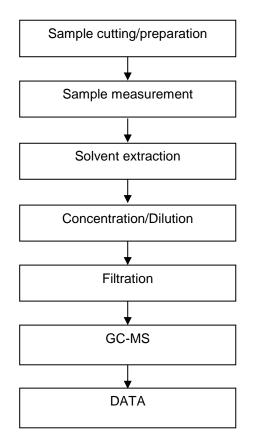

Halogen Testing Flow Chart







