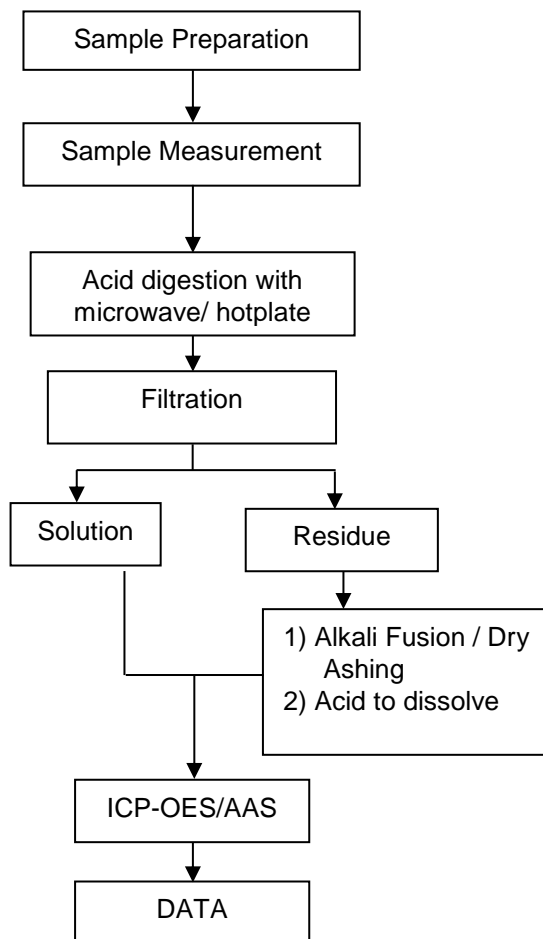

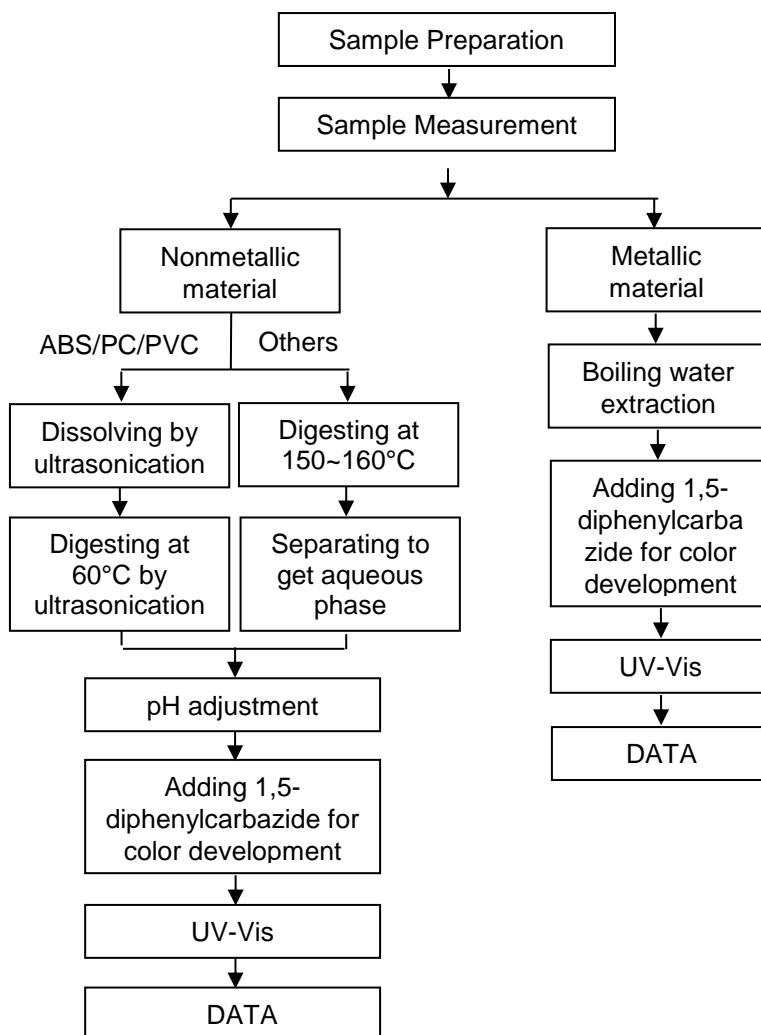

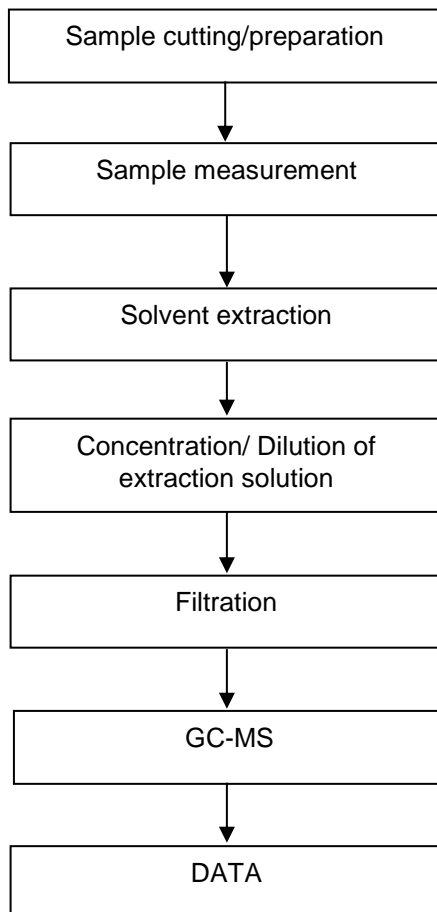

PBB/PBDE Testing Flow Chart



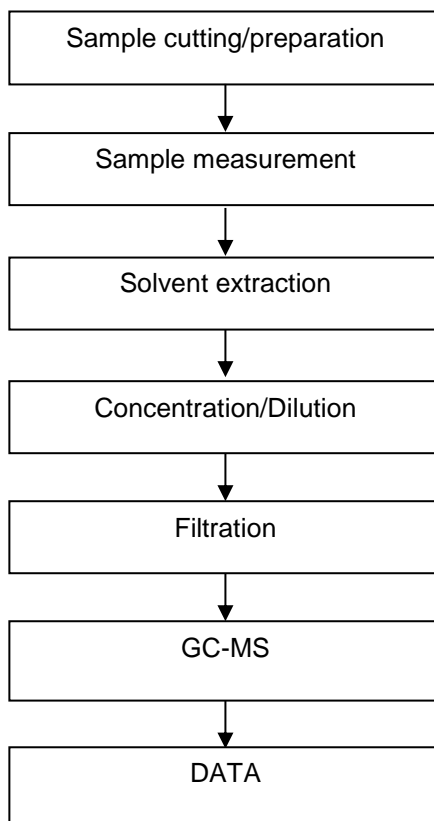

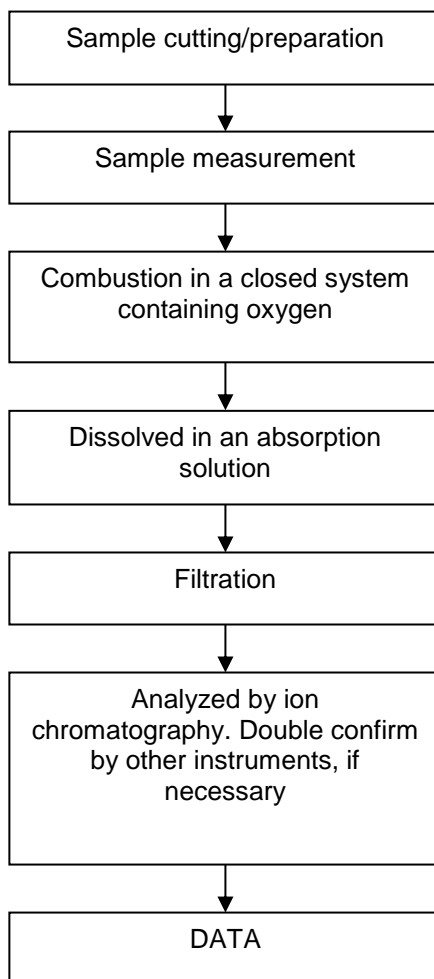
