





### **PBB/PBDE Testing Flow Chart**





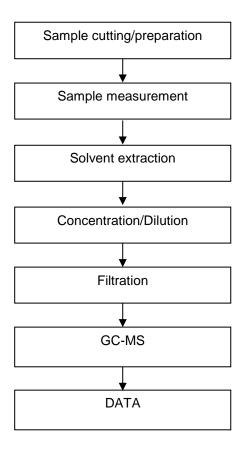

# **Phthalates Testing Flow Chart**





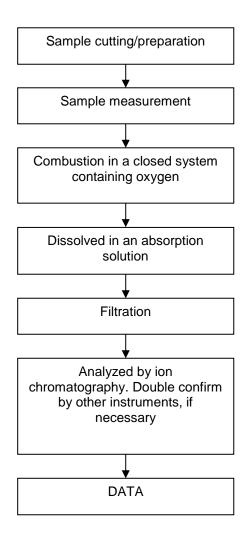


